Introduction

The European Council underlined in its conclusions on 22 March 2024 the importance of a resilient and sustainable agricultural sector for food security and the Union's strategic autonomy and the value of vibrant rural communities. In particular, the European Council reverted to the current challenges in the agricultural sector and concerns raised by farmers. Against this backdrop, the European Council invited the Commission to take work forward on easing the farmers' financial strain by designing means of additional support, such as for example extending the temporary framework on State aid, and to report back to the next European Council.

It is in this specific context that the Commission seeks the views of all Member States on the existence of a serious disturbance in the economy of a Member State and on the current role of the Temporary Crisis and Transition Framework ("TCTF") in remedying such a disturbance, as well as the potential need for continued support especially for the agricultural sector.

The Dutch authorities currently have only one aid measure in the agricultural sector based on the TCTF (section 2.1). This concerns SA.112447 (2024/N) – Netherlands

TCTF: Scheme for subsidy additional financing for eco-activities. An (short) extension of section 2.1 TCTF, without an increase of the maximum aid amount of this section, is considered desirable to execute approved aid measures. The Dutch authorities consider an increase of the maximum aid amount not justified due to the current economic outlook. According to the Dutch authorities, if more possibilities for State aid are needed in the agricultural sector, the regular agricultural State aid frameworks should be amended to provide for structural solutions.
